Requests of this campaign? What is the total need?

You are being asked to make a 3-year, sacrificial commitment (above and beyond normal tithing) to fund the construction of a Children and Youth facility. The total campaign plan is \$3,000,000.

Why a 3-year commitment?

The commitments are spread across three years in order to ease the financial burden of raising our total campaign need.

How will the building be financed?

The project will be paid for from funds raised by the capital campaig The scope of the facility will be determined by the amount of funds generated by the campaign.

What about bank financing?

Acts 2 leadership has decided not to take on any additional debt to finance this phase of ministry. With the infusion of new campaign capital, Acts 2 will actually be less leveraged from a financial perspective. Interest rates are on the rise right now and leadership feels we are better off with our current fixed rate of 3.75% through June of 2023, than we would be to pay down the current debt and take on new building debt at a higher rate.

The new student and youth facility will sit between our current Sanctuary Building and Frontier Elementary School.

We own 35 acres of land and have plenty of space for this building and future needs. In order to be tied into the city sewer for the first time, we will place this building to the south of our current Sanctuary building.

What is a sacrificial gift?

Sacrificial gifting is giving up something of value to invest in something of greater value.

How do I know what to give? Is there a formula?

Spend time in prayer continually seeking God's will for your involvement. There is no easy answer or quick accounting for a capital stewardship commitment. The best measure of stewardship is equal sacrifice, not equal gifts. Each person in proportion to their blessings can meaningfully invest in what God is doing at Acts 2. How does one gauge how "right" a commitment decision might be? Try the questions below to discover your own internal measures.

What should I consider?

Will this commitment cause me to invest myself in God's work through my church?

Will I take time to pray about this decision, genuinely, seeking how God might work through me? Will this giving decision involve a sense of sacrifice in my life?

Am I finding a joy in giving as I experience how freely and deeply God gives to me?

A loving nursery ministry serving 110 infants and toddlers weekly.

More than 100 youth experiencing Christian community together on Sundays and Wednesdays.

35 youth confirmations with 12 baptisms on Confirmation Sunday 2018.

Some 60 children learning about Jesus in our Children's Day Out Program.

200 adults in 15 small groups doing life together and living out our mission

65 Mothers of Preschoolers (MOPS) and 75 of their children sharing community twice monthly.

55 children from the community participating in YMCA Summer Camp on the Acts 2 campus

3 Girl Scout troops, 1 Girl Scout Service Unit, and several HOA's meeting regularly in our Facilities.

More than 400 youth and their families using the fields for soccer, baseball, football, lacrosse practice an YMCA games.

We have **welcomed more than**400 new members
since opening the new sanctuary.

Appreciated Assets: Consider transferring appreciated assets (stocks, real estate, etc.) to increase giving potential.

Sale of Assets:
